2025-26 Fast-Track 100-Hour Training Cohorts

Announcing our **Fast-Track 100-Hour Training Cohorts** for postgraduates with clinical licenses. Our program focuses on Section I and Section IV of the NYS Office of Addiction Services and Supports (OASAS)-approved standardized curriculum. The course includes 85 hours of live CASAC instruction, with the remaining 15 hours completed through free, asynchronous Ethics classes via the OASAS web portal. Each session runs six hours, allowing students to complete the program within an average timeframe of 3-4 months.

Our Offering

Our Fast Track program focuses on interactive learning. All classes take place virtually via Zoom. (You will need a desktop computer, laptop, or tablet with a functioning camera, microphone, and speakers.) In addition, you will have 24/7 access to educational activities and content in Google Classroom.

Eligibility Requirements

You may be eligible for our Fast Track program if you have a Master's degree (or higher) that leads to a clinical license from the New York State Education Department in at least one (1) of the following areas:

- 1. Licensed Master Social Worker/Licensed Clinical Social Worker
- 2. Licensed Mental Health Counselor
- 3. Licensed Marriage and Family Therapist
- 4. Licensed Creative Arts Therapist
- 5. Licensed Psychologist

Scholarship Requirements

For our scholarship program, you must complete, within one (1) year, 100 (clocked) hours of coursework and a minimum of 35 hours under the appropriate level of supervision in an appropriate New York State-certified setting: OASAS, Office of Mental Health (OMH), or Department of Health (DOH).

You must complete the Samaritan Daytop Village Intake form, and the NYS OASAS Application, Attestation, and Employment Verification Forms**, and send two letters of recommendation to training@samaritanvillage.org.

Cohort Schedules and Cost

Full-day, six-hour, Sunday classes from 10:00 a.m. - 4:00 p.m. Cost for the Fast Track program is \$1,700.

- Cohort 1: September 15, 2025 December 28, 2025
- **Cohort 2:** February 8, 2026 April 26, 2026

- * Please note: Priority must be given to individuals who are working at OASAS-certified, funded, or otherwise authorized programs/services (including but not limited to treatment, prevention, recovery, and risk reduction programs), OMH- and/or DOH-certified Integrated Outpatient Services (IOS-SUD), and DOH Drug User Health and/or Risk Reduction programs at the time of application.
- ** Individuals who are working at an OASAS/OMH/DOH program must complete the Employment Verification Form, which can be used in lieu of one letter of recommendation.
